



Reducing Tuition Cost Through: Student Referral Program

Who is eligible for the credit?

Parents (or guardians) of children currently enrolled in RCS schools are eligible for referral credits. To be eligible for each semester's referral credit, the referring family must have at least one student enrolled for that semester.

***Who is eligible to be referred?**

Children from families who have *never before enrolled a child in an RCS Campus are eligible*. To be eligible for the entire \$300 credit, referred students enrolled in grades K-12 must be enrolled full time for an entire school year. Preschool age children must be enrolled in a full-time childcare program for a full year.

Preschool age children enrolled in our "Jr. Kindergarten" or Preschool only" programs or in part-time child care (less than 5 full days a week) qualify the referring family for a \$100 total referral credit.

When will the credit be applied?

Semester tuition credits will be applied on January 15 and April 15. January credits will be applied for referred students enrolled prior to September 15 who remain currently enrolled as of January 15. Second semester credits will be applied April 15 for those who remain currently enrolled as of that date. First semester credit will be applied April 15 and before February 8, and remain currently enrolled as of April 15; the 2nd semester credit will be applied the next January, provided the referring family is still enrolled and the referred student has completed a full school year.

How many students can we refer?

The more the better !!! The limit of credits available to a referring family is 100% of tuition, (net of any financial aid or discounts) for the current semester for the referring family's currently enrolled (grades K-12) children, or 50% of the annual child care/preschool fees, per credit date, for preschool age children.

How do we make sure we get the credit?

To qualify for the credit, both the referring and referred family must submit a Student Referral Form. If two or more families claim a referral credit, the family named by the referred family will receive the credit. Student Referral Forms must be submitted within 30 days after the referred student is enrolled.

*No compensation other than tuition credit is available under this program. Referral credits will be applied to any outstanding charges on the family account; credit balances remaining at June 30 will be refunded. Monthly FACTS payments for February and May will be reduced by the tuition credit amount, provided the account is current.

Financial Aid

Rainier Christian Schools provides Financial Aid for families based on need. Program policies and financial aid applications are available at each campus or at our website: www.rainierchristianschools.org.

Financial aid information is kept in strict confidence. Eligibility and level of financial aid is determined by a needs assessment based on a variety of factors. Financial aid levels generally range from 10% to 25% of tuition for eligible families. In extenuating circumstances, financial aid may exceed these levels.

Families whose primary income is from full time ministry, such as missionaries and pastors, are eligible for a tuition discount. Additional financial aid for these families will be determined by a needs assessment, based on the financial aid application.

RCS policies limit the amount of financial aid that can be allocated from the General Fund. However, designated 'scholarship' gifts are received each year, allowing us to help more families.
